Business Domain (What we do.)

The business domain of Aleph Naught Records & Computing Ltd. is acting as a Musical Record Label. Furthermore, Aleph Naught Records & Computing Ltd. is an Independent Record Label. As of year 2023, our Independent Record Label distributes using the TuneCore distribution platform.

The musical artists associated with Aleph Naught Records & Computing Ltd. are restricted to artists that engage in musical collaborations with Valentin B. Bura. Hence in order to qualify as one of our productions, Valentin B. Bura must have been declared as a contributor in the TuneCore splits.

All artists contributing creative input will be remunerated according to, and directly proportional to the splits specified to the Music Distributor (TuneCore), and/or according to the sole discretion of the members in the Board of Directors.

As of 2023 the sole object of business that Aleph Naught Records and Computing Ltd. is engaging in is acting as a Musical Label.

What we do not do.

Valentin B. Bura and Aleph Naught Records & Computing shall not engage in any form of business with the following types of individuals and entities:

- 1. Individuals or entities that have murdered, whether or not convicted of that felony;
- 2. Individuals or entities that have engaged in theft or financial fraud, whether or not convicted of that felony;
